Developing solutions that bring the system environmental, social and economic advantages is the main focus of our organisation, and is incorporated into all aspects of our business, starting with the products themselves, the production process and maintenance, the supply chain, and even includes our way of communicating to, and integrating with, the community.

We continually seek to improve our performance, by assessing technical, economic and social contexts and developing strategic partnerships, in which we share experiences and skills. We develop effective collaboration systems, by establishing and maintaining profitable working relations with the internal and external stakeholders throughout the supply chain, both upstream and downstream. - Respect the applicable laws, the rules, the standards and, when appropriate, food safety standards and the customer's requirements; in the event of there being no appropriate law or standard, Novamont adopts and applies standards and methods that reflect their commitment to complying with the QEHS requisites, the best available techniques and the company's expectations.
- Establish measurable objectives and targets by which QEHS performance can be monitored and improved;
- Adhere to the principles of sustainable management of resources, prevention of pollution, environmental management, safety and sustainability of products, also by signing international voluntary programs that promote such principles.
- Demonstrate a clear commitment of management in the continuous improvement of QEHS performance;
- Consult with employees and communicate with the relevant stakeholders, over the development and improvement of the management system;
- Ensure that employees, service suppliers and contract workers have the adequate resources, information and training necessary to complete their work competently and safely, in such a way as to ensure that the system's objectives are achieved, in terms of compliance of the products and of the services.
- Ensure that all employees carry out actions intended to prevent accidents, by applying risk management procedures related to their work;
- Identify, report, record and analyse any accidents and unplanned events, in order to learn from them and to implement corrective and preventive actions;
- Regularly examine the effectiveness of the integrated QEHS system, using assessment and auditing processes.
